Ms. Norton was a founding member of the Pittsburgh firm now known as Picadio Sneath Miller & Norton, P.C. She wrote the first edition of this book, which was published in 1997, and the 1998 supplement. She was working on the second edition when she passed away unexpectedly in 2002. Following a clerkship with federal judge Maurice B. Cohill, Jr., she entered private practice in 1980, where she tried dozens of cases in both state and federal courts, argued before all the appellate courts in Pennsylvania, and served as an arbitrator, mediator, and expert witness in insurance coverage and bad faith litigation. Her practice was concentrated in civil litigation, particularly insurance coverage and bad faith disputes, and she was named in the 2001 edition of *The Best Lawyers in America for Business Litigation/Insurance Coverage*. President Clinton twice nominated her to fill a vacancy on the bench of the United States District Court for the Western District of Pennsylvania, but the Senate never made a final decision on those nominations. Ms. Norton was also appointed to the Lawyers' Advi-

sory Committee for the United States Court of Appeals for the Third Circuit in 1997; was appointed to chair the Civil Justice Advisory Group for the Western District of Pennsylvania by chief judge of the district from 1995–98; was an adjunct professor of law at Duquesne University School of Law; and was a frequent lecturer in the legal community on insurance coverage, bad faith, corporate ethics, and professionalism in advocacy.
